Superintendent Ludens reported that the following bids for construction of the new elementary school were received and opened as per bid specifications:

Representatives from Hoogendoorn Construction and Dells Electric stated that the submitted subcontractor's cost for electrical work was significantly lower because the subcontractor had only received partial information from their supplier until after the bid opening. They requested a bid increase of \$58,372 plus excise tax to cover their cost, with no mark-ups or fees. School attorney Gerry Kaufman recommended that the board postpone action until after executive session.

The superintendent reported on the fall student count for the school district and the kindergarten advisory task force.

**11-047** Motion by Davis, seconded by Randall, to approve the second reading and adoption of revisions to **policy AC and regulations AC-R** on equal opportunity/non-discrimination. All voted aye.

Superintendent Ludens reported that the middle school and high school drug and alcohol surveys from the Carroll Institute were available for review. He also reported that a survey of the

building principals indicated there were no written guidelines or policies for responding to email or posting grades on the parent portal. Principals have requested that staff respond to emails as quickly as possible, post grades as soon as available, and post assignments when given to students.

Gerry Kaufman reviewed open meeting and public record laws.

**11-048** Motion by Davis, seconded by Schuch, to enter executive session at 8:23 p.m. for the purpose of discussing legal communications, personnel, and contractual discussion with the school attorney (SDCL 1-25-2, 1 & 3). All voted aye.

Blankenfeld declared the board out of executive session at 9:00 p.m. and stated that contractual discussion with the school attorney was the only issued addressed in this executive session.

**11-049** Motion by Davis, seconded by Schuch, to accept the low base **bid** of \$9,569,000.00 from Hoogendoorn Construction for construction of the new elementary school. All voted aye.

School attorney Gerry Kaufman stated that SDCL 5-18A-5 does not allow a change in bid price after bid opening, and that his legal opinion is that the board does not have the legal authority to allow an increase in the bid as requested by the general contractor and sub-contractor.

The board discussed bid alternates.

**11-050** Motion by Davis, seconded by Randall, to approve Hoogendoorn Construction **add alternate** #4 to install bleachers in the new elementary school gym for a cost of \$41,000.00. All voted aye.

**11-051** Motion by Schuch, seconded by Davis, to go into executive session at 9:30 p.m. for the purpose of discussing legal communications and personnel (SDCL 1-25-2, 1 & 3). All voted aye.

Blankenfeld declared the board out of executive session at 10:13 p.m.

**11-052** Motion by Schuch, seconded by Davis, to approve a master's degree **lane change** for Jason Kurtz at \$1,500.00 and to further research Mr. Kurtz's request for lane changes to MA+16 and MA+32. All voted aye.

Blankenfeld adjourned the meeting at 10:14 p.m.
