

## PARTICIPANT AGREEMENT RELEASE & ASSUMPTION OF RISK

In consideration of services of Lazer Assault, their agent, owners, officers, volunteers, participants, employees and all other persons or entities acting in an capacity on their behalf I hereby agree to release, indemnify, and discharge Lazer Assault on behalf of myself, my spouse, my children, my parents, my heirs assigns personal representative and estate as follows.

1. Any and all claims associated with the operation of the mechanical bull as it is a dangerous ride and may cause serious injury or even death, this release is given for all claims arising from its operation past present or in the future.
2. I acknowledge that my participation in riding a mechanical bull entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the qualities of the activity.

Risks include among other things being thrown from the bull that could result in musculoskeletal injuries including head, neck and back injuries.

Furthermore, Lazer Assault employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in the activity is purely voluntary, and I elect to participate in spite of the risks.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Lazer Assault from any and all claims, demands and causes of action, which are in any way connected with my participation in this activity or my use of Lazer Assault equipment or facilities, including any such claims which allege negligent acts or omissions of Lazer Assault.
5. Should Lazer Assault or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force effect.
7. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating or else I agree to bear the costs of such injury or damage to myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

By signing the document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Lazer Assault on the basis of any claims from which I have released them herein.

I give Lazer Assault permission to record my ride for insurance purposes and I also release the use of my image to be used by Lazer Assault for any advertising or promotional use.

I have had sufficient opportunity to read this entire document, have read and understand it and I agree to be bound by its terms.
