# **Change coming to South Dakota classrooms**

As you talk with your children about their experiences in their English language arts and math classes this year, you may notice some differences. The changes are likely the result of South Dakota's new standards in English languages arts and math, called the South Dakota Common Core.

The standards are referred to as "common" because about 45 states came together to develop this shared set of expectations for what students should know and be able to do at each grade level.

The South Dakota Board of Education approved the new content standards in English and math in November 2010. The adoption of standards for the various content areas is not a new process. It has been going on for years, and the South Dakota Board of Education is the governmental body tasked with evaluating and adopting content standards.

Content standards provide a framework for what students should know and be able to do at each grade level. Decisions about curriculum, including how the standards will be taught and selection of textbooks and other instructional materials, are made at the local level, just as they always have been.

One of the most exciting things about these new standards is that they are aligned to current expectations for college and career readiness. They challenge students to think more deeply and to be able to apply that knowledge to real-world situations. They emphasize skills such as critical thinking, problem solving, communication, and the ability to construct viable arguments and critique the reasoning of others. These are all skills identified by employers as necessary for success in today's globally competitive world.

Across the district, we have been immersed in the process of training teachers and staff, so that they are familiar with the standards and understand the shifts in instruction that go along with the standards. Any time we make the move to new standards, it is a challenge. However, high quality standards are a critical foundational piece in ensuring that our students are prepared for success in college, careers and life in the 21st century.

We will be providing more detail on the standards throughout the year. In the meantime, you can visit www.commoncore.sd.gov to find out more, and if you still have questions or concerns, please don't hesitate to contact your school principal, or your child's teacher.

# Class of 2014 Information

**Graduation Date** - Commencement is scheduled for Saturday, May 17, 2014, at 2:00 P.M. in the High School Gym.

**Senior Pictures** - Seniors may have their senior photos taken by whomever they choose. However, it is important to schedule the photos as soon as possible if this has not already been done. We do not encourage students to miss school to have their senior pictures taken, so it is a good idea to get this scheduled during school vacation periods.

Caps and Gowns - Caps and gowns are ordered shortly after Christmas. Payment for the cap and gown is made at the time they are ordered. Generally the cost is \$50. Extra tassels in school colors may be purchased at the time the caps and gowns are ordered for an additional fee.

Senior Composites - Photos for the senior composite will be taken at the school on August 27, 2013, by Photography By Mark. All seniors must take the photos for student identification purposes, but are not required to purchase them. If a senior wishes to submit another photo for the senior composite it must be turned in and approved by the office before December 1, 2013.

**Announcements** - Graduation announcements are ordered through Josten's after the beginning of the second semester. Josten's meets with he senior class to discuss design. It is the student's responsibility to order their own package from Josten's and make payments accordingly. This is an optional service as seniors are not obligated to order from Josten's.

**Senior Privileges** - Students with signed parent consent forms are granted Senior Privileges during their final year. This means seniors are allowed to leave the high school during a free hour or during lunch. It is important to remember these privileges may be lost if poor attendance or disruptive behavior becomes an issue. Seniors do at times become eager to complete this phase of their education without remembering their top priority is attending school and completing their very best work possible. This open free period and lunch are privileges which come only when other responsibilities are met.

The Board of Education meetings are held on the second Monday of every month, and fourth Monday of every month, except July and December. BOE meetings begin at 7 p.m. and are held in the Distance Learning Room at the High School. Agendas can be obtained from the Superintendent's office on the Friday before any meeting. The Dell Rapids Tribune publishes the minutes of each regular and special meeting. Agendas and minutes are also posted on the school website.

# **INSURANCE NOTES:**

The school does not carry insurance to pay for school related accidents. If an accident occurs, all costs from the accident are the responsibility of the person having the accident. Individuals are encouraged to carry accident insurance. Student accident insurance is available through Student Assurance Services, Inc. of Stillwater, MN. The school district had brochures available at registration and will continue to have them available in the school offices. To be eligible for coverage, the envelopes must be returned to the school. Claim forms will be available from the principal throughout the year with coverage subject to the terms of the plans listed on the brochures. The school district does not attempt to become an agent for the company and further questions may be directed to insurance agent David Desch at 1-800-328-2739.

# **School District Wellness Policy**

In accordance with federal requirements, the Dell Rapids School District has adopted a Wellness Policy and Regulations that support student achievement and the development of lifelong wellness practices through the promotion of healthy eating and physical activity. The policy includes nutrition, physical activity, nutrition education, and other school-based activity components. A committee of school board members, school administrators, food service and health professionals, teachers, parents, and students meets annually to review the policy and recommend changes to the school board.

The goal of the physical activity component is to provide opportunities for students to develop physical activity skills, maintain physical fitness, and understand the benefits of a physically active and healthful lifestyle. Physical activity will not be used as punishment, and use of physical activity time for make-up work and testing will be limited.

Nutrition standards require that federal requirements are followed in the school lunch and breakfast program. Teachers and parents are encouraged to include healthful food choices for snacks, parties, and celebrations, and the use of food is discouraged as a classroom incentive. No soda will be sold in school vending machines and in the high school, vending machines will offer only foods and beverages on the District's preferred list of healthy foods.

# **SCHOOL LUNCH**

The Dell Rapids School District participates in the National School Lunch and Breakfast Programs. Lunchtime Solutions provides complete, well balanced, Type A meals that are attractive and satisfying to students.

All students are encouraged to enjoy the nutritious meals that include an all-you-can-eat salad bar. Students may buy breakfast for \$1.30 at each school. The daily price for lunch at the elementary school is \$2.40, and the daily price for lunch at the middle school and high school is \$2.50. The price for an Adult Meal is \$3.00. The price for an extra milk, or milk for elementary breaks, is \$.45. An Extra Entrée is \$1.55 and an extra pizza slice is \$1.75.

Applications for free and reduced price meals are mailed to each family with registration or open-house information and are also available in the principals' offices. Parents that wish to apply for free or reduced price meals for their children should return their application form to the business office. Students approved for free or reduced price lunches are also eligible to receive free or reduced price breakfasts.

A selection of a la carte items are available for purchase in the middle school and high school after the purchase of a complete meal. Parents are able to place restrictions on student purchases of a la carte items. Accounts may be restricted to allow no purchasing of a la carte items, to place a dollar limit on daily a la carte charges, or to allow a la carte purchases with cash only. To request account restrictions for the 2013-2014 school year, parents should call the business manager or food service director at 428-5473.

The district uses NutriKids computer software for record keeping. Each student has his/her own lunch account, and the district requires payment in advance for students to purchase meals or a la carte items. Any dollar amount can be deposited toward future purchases. It is recommended that deposits into students' accounts be made by check. Checks should be made payable to the Dell Rapids School District. Meals may also be purchased with cash at the point of service. Through the MySchoolBucks.com website, parents are able to use a convenient, easy and secure online prepayment service to deposit money into their child's school meal account. This service also provides parents the ability to view their child's account balance and print out a copy of their child's eating history report for the past thirty days. #### WARNING **E AHERA ASBESTOS**

In October 1987, the U.S. Congress passed the Asbestos Hazard Emergency Response Act. Asbestos is a fiber, which in the past had been used in building construction materials, and has been identified as being a disease-causing agent, including a cause of cancer. The purpose of the legislation was to insure that school students are provided with a safe environment in which to learn.

Asbestos abatement (removal) has been completed throughout the district. The only asbestos-containing materials that remain in the district are the asbestos vinyl floor tiles located throughout the district's buildings (except the middle school and the new elementary). The district's asbestos staff or contractors will deal with the floor tile as the need arises. Should any parent/patron have questions regarding the federal law or its application to our district, those persons are invited to direct their inquiries to Summer Schultz, Superintendent. 

# Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA), a federal law, requires that the Dell Rapids School District, with certain exceptions, obtain written consent prior to the disclosure of personally identifiable information from your child's education records. However, the Dell Rapids School District may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Dell Rapids School District to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs;
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish

# **USE OF SCHOOL FACILITIES**

Recognizing that the school facilities belong to the people, the Board of Education desires to cooperate with agencies and organizations within the school district by making school facilities available for their use.

For this reason, all rental and service charges have been kept as low as possible considering the operation and maintenance cost.

yearbooks. In addition, two federal laws require local education agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want the Dell Rapids School District to disclose directory information from your child's education records without your prior written consent, you must notify the building principal in writing by September 1st of each year. The Dell Rapids School District has designated the following information as directory information:

- \*Electronic Mail address
- \*Dates of Attendance
- \*Participation in officially recognized activities and sports

- \*Photograph

# SENIOR CITIZEN ACTIVITY PASSES

Senior Citizens (Age 62 & over) who are residents of the Dell Rapids School District can receive free admission to most Dell Rapids Public School athletic events. A card will be required to receive free admission. Free season passes may be picked up at the District office.

### **ACTIVITY TICKETS**

All elementary, middle and senior high students had an opportunity to buy activity tickets on their registration day. They serve as student identification for admittance to most athletic activities conducted by the Dell Rapids Public Schools. Activity tickets also serve as identification for student prices at other activities. The cost of a high school activity ticket is \$20.00. The cost of a middle school activity ticket is \$15.00. Any elementary school student may buy the \$15.00 ticket for use during the 2013-2014 school year. Adult 10-punch activity tickets are \$30.00. Adult All-Season Activity Tickets are \$50.00 each. Activity tickets will be available at the first home football and home volleyball games. Activity admission prices are \$5.00 for adults and \$3.00 for students. Dell Rapids senior citizens (age 62 and over) may pick up a free season pass for most athletic events at the District Office.

# Ag in Action

As the summer break draws to a close and students are getting ready to return to classes, the courses being offered in Agriculture Education for fall semester are: Introduction to Agriculture, Food and Natural Resource class where the students will have the opportunity to learn about the role of the FFA organization in Agriculture Education, define and discuss the concepts of natural resources, demonstrate an understanding of animal science systems, demonstrate an understanding of plant structure and function, relate basic food science technology principles to production agriculture, summarize basic food science technology, and summarize basic principles involved in agricultural systems technology. Those students will also have the opportunity to learn about shop tools and shop safety, project design and construct a small wood project. There will be two sections of the Ag Processing class for the fall semester. One of those sections will be a skinny class and will last the entire semester, while the other section will be a full block and last for a quarter. All of the Ag Processing students will have the opportunity to identify processing, handling, and storage factors and how they impact product quality and safety; identify processing inspection and laws pertaining to humane slaughter; understand the processing of other agriculture products in today's global economy; understand the packaging and preservation of food items.

In the second quarter following the first quarter of Ag Processing will be Fundamental Animal Science Class. The students will apply knowledge of anatomy and physiology to produce and/or manage animals in a domesticated or natural environment; recognize animal behavior to facilitate working with animals safely; provide proper nutrition to maintain animal performance; know the factors that influence an animal's reproductive cycle; identify environmental factors that affect an animal's performance.

A section of Wildlife and Fisheries will also be offered during the fall semester as a skinny class. In this class, students will recognize the importance of managing fish and wildlife and understand the importance habitat plays in their populations; identify key factors including economic and social issues related to fish and wildlife; identify life patterns of fish and wildlife.

Jackson Entringer, Riley Miller and Trevor Peter went on the FFA Reward Trip May 17, 18 & 19, 2013. Members earn points by participating in various events throughout the year. Once members have earned enough points, they are eligible to go on the trip. The trip details are then determined by those members. Those three members went to Valley Fair and the Mall of American on May 18 and a Minnesota Twins game on May 19. Colin and Lane LeBrun had qualified for the trip, but were unable to attend.

Austin Broin, Riley Jurgensen and FFA Advisor Tom Wolff attended the Washington Leadership Conference held June 4-9, 2013, in Washington, DC. Broin, the Dells FFA Chapter Sentinel and Jurgensen, the Dells FFA Chapter Secretary participated in an intense conference that covered the areas of authentic leadership, solving problems, building relationships, living with character and service in leadership. Over three hundred FFA members from across the country attended this leadership conference, with others attending the same conference during the five other sessions held during the summer. Part of the building relationships area included meeting with State Congresswoman Kristi Noem and two of Senator Tim Johnson's research assistants that deal with agricultural issues. The members also completed a service learning project which consisted of packing school supplies for inner city school students and teachers.

Dr. Seth Severtson and FFA Advisor Tom Wolff offered the FFA members an opportunity to gather and identify various leadership skills and suggest ways to enhance those skills. The members who attended the first session held on Monday, July 8, 2013, at the Dell Rapids Pizza Ranch were: Mason Hollaren, Hannah Huss, Elijah Johnson, Mariah Warne, Brittnay Welbig and Shelby Wrage. The focus was on what is leadership and what are the characteristics of a leader? A second session was held on Sunday, July 21, 2013, to continue building those skills and focused on communication with Mason Hollaren and Austin Machmiller in attendance. The final session was held on Tuesday, Aug. 6, 2013, with Mason Hollaren, Elijah Johnson and Heidi Ander-

son discussing ways to work with other people and how we can influence others. The topics covered over these three sessions can be utilized by the members not only in the FFA but throughout their lives. Austin Machmiller, the Dells FFA Chapter Treasurer, his dad Alan and Mr. Wolff, attended the State FFA Leadership Retreat at Camp Bob Marshall near Custer, SD on July 9 through July 12. Over ninety FFA members from across South Dakota attended this retreat. The retreat was organized and ran by the South Dakota State FFA Officers and this year's retreat was centered on a Dr. Suess theme focusing on "Oh the places you will go with FFA". While at camp, Machmiller and the other FFA members developed and enhanced their leadership skills and self-confidence through interactive learning. The program featured workshops that helped members discover the value of attitude, motivation, passion, personal growth, teamwork, and communication. They will use these new skills and ideas to benefit their local chapters and communities.

The SD Department of Agriculture organized a panel of agricultural industry professionals who spoke with FFA members about opportunities in agriculture. Retreat attendees also participated in a service learning project in conjunction with the City of Custer along with attending the lighting ceremony at Mt. Rushmore. Austin was awarded the "Green Eggs and Ham" award which was given to the member most willing to try new things.

The Sioux Empire Fair on August 2-11, 2013, in Sioux Falls had a special FFA division allowing FFA members to exhibit their livestock and compete against other members. The South Dakota State Fair will be held August 29 – Sept. 2 in Huron also has a special FFA division not only allowing members to exhibit livestock, but they can also enter agriculture mechanics exhibits, agri-science exhibits, horticulture exhibits and chapter exhibits. Any student enrolled in an agriculture class can join the FFA organization which can help prepare students for premier leadership, personal growth and career success.

If you would like more information about FFA, contact Mr. Wolff. The first FFA chapter meeting will be held on Monday, August 26th at 7 pm in the high school agriculture classroom.

# Common Core Standards design new classroom tactics

During the 2013-2014 school year, each issue of the *Wise Owl* will provide parents and community members information about the Common Core Standards in an effort to inform stakeholders and educational partners about a significant change taking place in school districts across the state and the nation.

This first issue will provide general Common Core information provided by the South Dakota Department of Education (Updated: 4/23/13).

#### What are Common Core Standards?

The South Dakota Common Core Standards provide a clear and rigorous set of expectations for what students (grades K-12) should know and be able to do in the subject areas of English-language arts and math.

#### The standards are:

- Research-based and aligned to expectations for college and career success
- Informed by the best models in the country
- Benchmarked to top-performing nations across the world
- Developed by teachers, principals, education experts and parents

How are they different from previous standards?

South Dakota has had standards in various subject areas, including English-language arts and math, for many years. In November 2010, the South Dakota Board of Education adopted updated standards in English-language arts and math (the Common Core).

#### The standards promote:

- Deeper understanding of the key concepts students need to succeed as independent thinkers
- Students' ability to apply knowledge to real-world situations
- Instruction that places more emphasis on understanding and application, as opposed to memorization and test-taking
- Richer, more authentic types of assessment

#### Why do we need them?

Growing global competition makes it critical that students graduate high school ready for the challenges of college and careers in today's knowledge-based economy.

The new standards are aligned with college and workforce expectations and establish clear expectations for students, including the ability to:

- Apply math in real-world situations
- Read and analyze both literature and informational text
- Construct viable arguments and critique the reasoning of others
- Solve problems
- Communicate effectively

Through this solid mastery of skills, the standards will fuel an even stronger workforce for the state.

The standards are internationally benchmarked, which means South Dakota students should be better prepared to compete for jobs with students from around the world.

Because 45 states have adopted these common standards, there will be consistency from state to state, which is important in today's highly mobile society. A fraction is a fraction whether you are in South Dakota or South Carolina.

How were they developed?

The effort to develop common standards among the states was led by the governors and chief education leaders in the 45 participating states. These two groups pulled together teachers, administrators, education experts, researchers and parents to reflect the best current thinking in education, the realities of the classroom, and aspirations for children. The federal government did not play a role in the development of the standards.

As with any adoption of academic standards in South Dakota, the new standards in English-language arts and math were brought before the state Board of Education for review and approval. The board voted to adopt the standards in November 2010. As with any academic standards in South Dakota, local districts determine how to teach and implement the standards – selecting their own curricula, instructional practices and materials.

When will implementation of the new standards take place? Teachers across the state have begun training on how to foster the deeper levels of understanding and higher-order thinking skills needed of students under the new standards. The standards should be fully implemented in school year 2013-14, with a new assessment to follow in 2014-15

What will the new assessment look like?

The new assessment, based on the new standards, will replace the current Dakota STEP test. The new test will incorporate more short answer and constructed response questions, as opposed to the current status quo of mostly multiple choice questions. It is also important to note that the new assessment will be delivered solely online, and districts are already preparing for this transition.

Do students still need to memorize math facts?

Yes. While the new math standards emphasize thorough understanding, (meaning students will know how and why concepts work) they will still require students to perform simple calculations quickly and easily.

Does classic literature have a place under the new English standards? Yes. While the new English language arts standards infuse more informational text into student reading, teachers will continue to teach literary classics as they always have. The English language arts standards do not limit reading to non-fiction but suggest a balance between literature and non-fiction texts (for example, the Gettysburg Address), so students can build knowledge and broaden their perspectives. This exposure to informational text will help students be prepared for the type of reading they will encounter in the workforce.

Is there federal money attached to the adoption of Common Core? The Common Core is not federally mandated, and South Dakota did not receive any federal money tied to adoption of the new standards.

Does the Common Core dictate curriculum for local school districts? No. The new standards in English-language arts and math are not curriculum. School districts still set their own curriculum, as they always have. It's important to understand the difference between standards and curriculum; the two terms should not be used interchangeably. Standards provide the framework of expectations for student knowledge and skills. Curriculum details how the standards should be taught and includes resources, materials and instruction.

In South Dakota, the state Board of Education is charged with adopting standards. Local school districts have the authority to decide how to teach and implement the standards, including the selection of instructional practices and materials.

# **Elementary and Secondary Education Act (ESEA) Reporting Information and Requirements**

The Elementary and Secondary Education Act (ESEA) requires all public school districts publicly report accountability and assessment results for the district and each of its schools, along with state performance on the NAEP test. It also requires schools to provide individual student results to parents. Distributing this information to parents allows them to know the status of student achievement in the state, the district and in the individual schools as well as the performance of their student(s).

#### South Dakota State Report Card

The new South Dakota State Report Card contains the required components for Accountability and Assessment Reporting under the ESEA.

#### Part One: Accountability Reporting

The public Accountability portion of the report card provides the public with information about student achievement on the Dakota STEP or Dakota STEP-A. It is based on the scores of students who were continuously enrolled in a single district from Oct. 1 to the last day of the testing window (FAY or full academic year). Please note: If a subgroup contains fewer than 10 students, no data from those particular students are reported.

The most recently available National Assessment of Educational Progress (NAEP) data in grades four and eight on reading and

math are reported as well. The data reported are state level (not district level) data.

## Part Two: Assessment Reporting

The Public Assessment Report part of the report card reflects the achievement of all students in a district or school – not just those who completed the full academic year as in the Accountability report. The Assessment Report includes Dakota STEP and STEP-A results in reading, math and science. Please note: If a subgroup contains fewer than 10 students, no data from those particular students are reported.
